

# St William of Perth Exclusion Policy

## **Mission Statement**

Our mission is to nourish the growth of all its members as persons illuminated by the light of Christ as our Catholic values permeate all aspects of school life.

We aim to provide a quality education where high standards of attainment and behaviour are expected. We encourage all our pupils to develop as life-long learners

as they strive to reach their full physical, intellectual and social potential.

This happens within an atmosphere of love, respect and tolerance of others in mutual co-operation within our School, Home and Parish family.

It is the policy of St William of Perth School to try to deal with all behavioural issues in an active, positive way, employing a wide range of strategies, including those specifically designed to avoid such issues reaching the point of fixed term suspension or exclusion. (See Behaviour Policy).

## **Principles**

- 1. Exclusion is a sanction used by the school only in cases deemed as serious breaches of the School Behaviour Policy. A student may be at risk of exclusion from school for: Verbal or physical assault of a student or adult; Persistent and repetitive disruption of lessons and other students' learning; Extreme misbehaviour which is deemed outside the remit of the normal range of sanctions.
- 2. A Fixed Term Suspension from the school can only be authorised by the Headteacher or the Deputy Headteacher acting on the Head's behalf. If none are available to authorise the exclusion a decision should be deferred until the opportunity for authorisation is available.
- 3. In the case of a Permanent Exclusion this can only be authorised by the Headteacher and must only be done after consulting the Chair of Governors of the intention to impose this sanction, although the final decision rests with the Headteacher of the school.
- 4. The school seeks to reduce the number of incidents leading to exclusions by promoting a positive atmosphere of mutual respect and discipline within the school.
- 5. The school regularly monitors the number of Fixed Term suspensions and exclusions to ensure that no group of students is unfairly disadvantaged through their use and that any underlying needs of individuals are being fully met.

# Notification of an Suspension/ Exclusion

1. Parents will be notified as soon as possible of the decision to suspend / exclude a student and the reason for the suspension exclusion. This will be done on the day of the suspension / exclusion being authorised by either direct phone contact or a face-to-face meeting. A written confirmation of the reason(s) for the suspension / exclusion will be sent to parents the same day.

- 2. In the case of a Permanent Exclusion parents will be notified by the Headteacher in a face-to face meeting.
- 3. Where possible a student who has been excluded will have the reasons for his/her suspension / exclusion explained to them by a member of staff so that they understand the nature of their misbehaviour. This may take place at a reintegration meeting.
- 4. The school will also work to put in place a programme for the pupil on his/her return. This will include input from staff at the school, parents, if appropriate, and any other appropriate bodies e.g. HSSW, Attendance Service or the Local Authority. Should it be decided for whatever reason that the matter needs to be put in the hands of another agency i.e. the incident leads to the discovery that there is a child protection issue, the school will continue to monitor the situation and work closely with that agency. It is hoped that in most cases following an suspension / exclusion, the child will be able to return to school and that further input will promote in him/her a more positive attitude and a subsequent improvement in behaviour.
- 5. The Chair of Governors, LA inclusion Officer and relevant school staff will be notified of all Fixed Term Suspensions / Exclusions the same day of the production of the suspension / exclusion letter, which they will receive a copy of; it will clearly outline the reasons for the suspension / exclusion.

### **Students Returning from a Fixed Term Suspension**

Students returning from a Fixed Term suspension may be required to attend a reintegration meeting accompanied by a parent. If the student has been excluded for over five days in one term, they will be required to attend a reintegration meeting accompanied by a parent. This meeting will seek to establish practical ways in which further exclusion can be avoided and behaviour modified to acceptable standards in partnership between student, parent and school.

## **Permanent Exclusions**

The school will usually only permanently exclude a child as a last resort, after trying to improve the child's behaviour through other means. However, there are exceptional circumstances in which a headteacher may decide to permanently exclude a pupil because of ongoing issues or even for a 'one off' incident. If your child has been permanently excluded, be aware that: - The school's governing body is required to review the headteacher's decision and you may meet with them to explain your views on the exclusion - If the governing body confirms the exclusion, you can appeal to an independent appeal panel organised by the local authority - The school must explain in a letter how to lodge an appeal - The local authority must provide full time education from the sixth day of a permanent exclusion.

## **Appeals**

All correspondence regarding an exclusion from the school will inform parents of their right to appeal to the Governing Body against the decision to exclude. This procedure is clearly set out in the statutory guidance. The person who should be contacted to initiate an appeal is the Clerk to the Governors.

# **Procedure for Appeals**

If parents wish to appeal against the decision to exclude, the matter will be referred to the governing body. Two governors, who were not involved in the initial decision to exclude, will acknowledge the complaint and schedule a hearing to take place as soon as practicable and normally within five days. Records relating to the decision to exclude and the parents' complaint will be

copied to all parties not later than two days prior to the hearing. In no circumstances however will the school or its staff be required to divulge to parents or others any confidential information on or the identities of pupils or others who have given information which has led to the exclusion or which the Headteacher has acquired during an investigation. The parents may be accompanied to the hearing by one other person. This may be a relative, teacher, friend or Parent Support Advisor. Legal representation will not normally be appropriate. If possible the governors will resolve the parents' complaint without the need for further investigation. Where further investigation is required, governors will decide how it should be carried out. After consideration of all the facts considered to be relevant, the governors will reach a decision on whether to uphold or rescind the exclusion or make other recommendations. This decision will be made within ten days of the hearing. St William of Perth RC Primary School Parents will be informed in writing of the governors' decision and the reasons for it. Their decision will be final. The governors' findings and any recommendations will be sent in writing to the parents, Headteacher and governing body. Parents are entitled to appeal against a governing body's decision if it has upheld the Headteacher's decision to permanently exclude their child; even if they did not make a case to, or attend, the governors' meeting.

#### **Behaviour outside School**

Pupils' behaviour outside school on school trips and sporting events is subject to the school's behaviour policy. Negative behaviour in such circumstances will be dealt with as if it had taken place in school.

### Relationship to other school policies

The Exclusion Policy should be read in tandem with the school's Behaviour Policy as well as other relevant school policies, particularly the Special Educational Needs Policy and the Equality and Diversity Policy. It also has a close inter-relationship with the Anti-Bullying Policy and Attendance Policy.

## **Monitoring and Review**

- 1. The impact of this policy will be reviewed by the governors' Curriculum Committee.
- 2. The headteacher will provide the Committee with regular monitoring reports which will help it to evaluate the effectiveness of the policy and procedures.
- 3. The policy and procedures will be reviewed and amended in the light of such evaluation and in consultation with representatives of all key stakeholders.
